Horowitz Horowitz Institute for Intellectual Property In memory of Dr. Amnon Goldenberg (hereafter: the Institute) wishes to promote research in the field of Intellectual Property (IP), *inter alia* by inviting junior visiting scholars to spend some time at the Institute.

2. Eligibility

- a. The applicant should be either a doctoral student in his or her last year, or within three years after receiving their doctoral degree, not yet employed at any academic institute, and devote most of his or her time to research.
- b. Students at Tel-Aviv University (TAU) may not apply for the fellowship.
- c. The topic of the research should be in any of the fields of IP.

3. The fellowship

- a. The fellowship is suitable for eligible scholars who are interested in spending no more than one month and devote his or her entire time to research in IP.
- b. The fellowship consists of a one-time grant of up to U.S. \$2500, towards a research visit to the Institute @ TAU Law Faculty. The fellow may use the grant to cover flight, accommodation and research costs. The Institute cannot cover these costs independently of the fellowship.
- c. The fellowship is merit-based.
- d. During the visit at TAU Law, the fellow will have full access to library services; is welcome to attend courses and workshops at TAU Law, and participate in the Institute's and Faculty conferences and symposia. Most of the activities at TAU Law are conducted in Hebrew. A few courses, however, are taught in English by distinguished visiting professors.
- e. The fellow may not provide work to the Institute, and there shall be no employment relationship between the Institute and the fellow.

4. Application

- a. The application will be submitted within the deadline published in the call for fellowships.
- b. The application should include:
 - i. The filled form provided in the appendix;
 - ii. Academic CV;
 - iii. List of publications;
 - iv. A research proposal of up to 500 words in English;
 - v. Letter of recommendation by the applicant's supervisor or other suitable academic authority;
 - vi. The applicant shall list prior fellowships that are available to him or her at the time of the application regarding the research proposal;
 - vii. Consent to these rule.

5. Review process

a. The Institute's Director and one other member of the Institute's academic committee will review the applications and make decisions. In case of a conflict of interest, another member of the academic committee will substitute.

- b. Criteria for awarding the fellowship are the importance of the proposed research, its novelty, and predicted contribution to the field of IP. The Institute may take into consideration other funds that are available to the applicant, regarding the proposed research.
- c. The Institute is not obliged to allocate the entire funding available each year, may decide not to allocate any fellowships in a given year, or divide the fellowship as it sees fit.
- d. The institute's decisions are final.
- e. The institute's decisions of acceptance will by publicized.

6. Conditions

- a. **Tax**. The fellowship may be subject to tax laws. It is the receiver's obligation to follow relevant laws.
- b. **Medical insurance**. Non-Israeli fellows must present proof of medical insurance (at their own cost), for the entire duration of the fellowship, prior to their visit. This is a strict condition. Without such proof, the fellowship will not commence.
- **c. Publicity**. The Institute may, at its sole discretion, publish the fellowship, the fellows and their research topics in the Institute's publications;
- d. **Acknowledgment**. The fellow will acknowledge the Institute's support in the relevant publications, in line with the custom and form in the publication.
- e. **Final report**. No later than 6 months after the completion of the fellowship, the fellow will submit a final research report of up to 500 words in English, including any publications which are the result of the fellowship. The Institute may publish the reports in whole or in part on its website and other publications.
