19. **THE DAVID BERG FOUNDATION INSTITUTE STUDENT FORUM**

The Berg Forum for Law and History, made up of students interested in the field, conducted an active program of meetings with legal historians, based on readings of published works and works in progress.

At the first meeting of the year the forum hosted Prof. Morton Horwitz (Harvard) to discuss his notable works and the historic perspective on relations between the U.S. Supreme Court and the presidency. The next meeting, hosted by Dr. David Schorr (TAU), was dedicated to historical research in a digital era. The third session focused on the history of mass-incarceration in the United States – with a screening of the Netflix documentary "The 13th", accompanied by a discussion with Dr. Yael Sternhell (History, TAU).

The spring semester focused on Israeli history. The first meeting featured Nomi Levenkron, a doctoral student at TAU Law, talking about the history of prostitution in Israel. Next Prof. Orit Rozin (History, TAU) discussed her new book, *A Home for All Jews: Citizenship, Rights, and National Identity in the New Israeli State*. The forum concluded the year with a screening of the documentary "Gay Days" and a discussion with Prof. Aeyal Gross (TAU) about the history of the LGBT legal struggle for equality in Israel.

Students and the guest speakers alike reported great satisfaction from the meetings.

RESEARCH

20. ISRAELI LEGAL HISTORY ARCHIVE

The nascent archive of Israeli legal history took its first steps this year with two projects, carried out with the assistance of TAU's David J. Light Law Library and with funding from the Zimin Foundation:

First, the library's collection of LL.M. theses was digitized. Digitization will make these works of legal research available to scholars around the world, including to historians of Israeli law, politics, and society.

Second, the family of the late Professor S.Z. Feller of the Hebrew University Faculty of Law donated his papers to the Archive. Prof. Feller was the leading Israeli expert on criminal law in the crucial years of the enactment of Israel's central criminal legislation, and his papers include his work on drafts of the legislation. The library staff took steps to physically preserve these materials and make them available to researchers. We now hope to proceed with detailed cataloging of the papers and their digitization.

In addition to ongoing work on the Feller Papers, planned work for the Archive in the near future includes the continued collection and accessioning of the papers of several Israeli lawyers and legal scholars.

A lively symposium was held to celebrate the event (see above at #15).

The publications committee (Dr. David Schorr (chair), Prof. Roy Kreitner, Prof. Assaf Likhovski, Prof. Orit Rozin) was also pleased to be able to approve publication of the second book in the series, once again in cooperation with Open University Press: Rivka Brot's *Between Community and State: Trials of Jewish Collaborators with the Nazis*. Brot's manuscript was winner of the prestigious Goldberg Fund Prize in 2016, and received rave reviews from our referees. We look forward to its publication in 2018.

23. **RESEARCH RESOURCES ONLINE**

After several years of work, the Institute recently released a major upgrade to its bibliography of Israeli legal history: https://en-law.tau.ac.il/Berg_main/Israeli_Legal_History_Bibliography. In addition to expanding its coverage to 1977, the website now contains nearly 40 subject-specific bibliographies, a step which has radically increased the utility of this research tool. We continue to solicit and search for additional sources, and update the lists on an ongoing basis.

25. PRIZE FOR BEST LEGAL HISTORY ARTICLE

Multiple Voices and the Force of Custom on Punishment: Trial of 'Family Honor Killings' in Mandate Palestine

Continuing the tradition begun last year, this year's annual conference of the Israel Law and History Association (see above at #2) included the award of a prize to author of the best legal history article published in the preceding year by a member of the Association. The prize committee, Prof. Menachem Mautner (TAU, Chair), Prof. Amichai Radzyner (Bar-Ilan), and Dr. Iris Agmon (Ben Gurion) as members, chose as the winner this year an article by Badi Hasisi and Deborah Bernstein, *Multiple Voices and the Force of Custom on Punishment: Trial of 'Family Honor Killings' in Mandate Palestine*, published in the February 2016 issue of *Law and History Review*.

The committee for the third annual prize, to be awarded this October 2, is chaired by Prof. Deborah Bernstein of the University of Haifa, and has already chosen the winner of the 2017 prize (yet to be publically announced).
