

# About Theoretical Inquiries in Law

Theoretical Inquiries in Law (TIL) is a biannual English-language law journal published by the Cegla Center for Interdisciplinary Research of the Law at the Buchmann Faculty of Law, Tel Aviv University. The journal specializes in the application to legal problems of insights developed in other disciplines, such as moral and political theory, epistemology, history, cultural studies, social sciences, economics and game theory, probability theory, and cognitive psychology. Contributors to the journal are distinguished legal scholars working in different interdisciplinary fields.

TIL is ranked <u>fourth</u> in the category of jurisprudence and legal theory worldwide and <u>first</u> among all non-U.S. law reviews, and is well-known and widely cited in Israel and all over the world.

Each year TIL publishes one volume, which is comprised of two issues. Each issue contains articles dedicated to a distinctive topic of law or legal theory, contributing groundbreaking research and new insights in the field. All issues are based on biannual international conferences that are held by the Cegla Center for Interdisciplinary Research of the Law. Prominent researchers (who also serve as guest editors) organize the conferences.

# The 2021-2022 Editorial Board

The issues that the incoming editorial board is to edit are *The Global Law Market: New Frontiers for Economic and Empirical Analysis for Private International Law* (issue 23.1, guest editor: Alon Klement and Daniel Klerman) and *Labor Agreements and Migrant Workers' Right: Starting A Conversation* (issue 23.2, guest editors: Hila Shamir, Tamar Megiddo and Adam Chilton). The *Global Law Market: New Frontiers for Economic and Empirical Analysis for Private International Law* conference will take place in January 2021. The *Labor Agreements and Migrant Workers' Right: Starting A Conversation* conference will take place in June 2021.

We welcome second-year students and above to apply to become editorial board members, who are involved in all stages of the editing process: participation in the conferences at which the articles are presented, suggestion of substantive comments, technical editing of footnotes and proofreading of the final text. Editorial board members gain valuable experience while handling academic articles in English and becoming proficient in the Legal Bluebook citation system, used by leading law reviews. The editorial board members are exposed to cutting-edge legal research by leading scholars from all over the world.

Editorial board members are entitled to <u>four academic credits</u> for their work and are committed to a tenure of approximately a <u>year and a half</u> (December 2020 to March 2022). The work includes attending training sessions editing meetings, and enrichment classes, which are scheduled while taking the editorial board members' schedules into account, especially exam periods. Please note that the editorial board's work continues over summer break; however, students are permitted to participate in any foreign exchange programs (the editing process will continue remotely).



# **Application Process**

Interested applicants will submit the following by e-mail to Ayelet Avriel, at <u>Cegla@tauex.tau.ac.il</u> by November 2<sup>nd</sup>, 2020 at 12:00:

- 1. Résumé (can be in Hebrew or English)
- 2. Current grade transcripts
- 3. Take-home exam
- 4. E-mail address, telephone number and picture

Relevant applicants will be invited for an interview, which will take place during the 16<sup>th</sup> and the 25<sup>th</sup> of November, 2020. The interview will include a discussion on the exam and personal questions, and will be held in Hebrew or English (according to the applicant's choice).

Note that the TIL editors reserve the right to disqualify applicants who are suspected of cheating on the take-home exam. The take-home exam should be the applicant's own work, as it is supposed to reflect his or her editing skills.

Please note that, should an applicant apply to more than one law review, they will be asked to state their preferences between the reviews. These preferences need to be stated only after the last interview (via an online questionnaire that will be sent to the applicant). Preferences will be taken into account only after the interviews and will not be revealed to each law review prior to the final division between the law reviews.

# Instructions for the take-home exam

Read the article *Voluntary Obligation and Contract* (available <u>here</u>). Write **up to five comments, in English, containing up to 120 words each**, about how you think the text could be improved. One or two of your comments should address the text as a whole while the other comments should address specific portions of it. In the comments, we suggest addressing some of the following issues: the clarity and structure of the article, the main claim of the article and its grounds, missing information, repetitiveness, logical flaws, etc. Do not address any grammatical errors. Please note that you will be required to discuss this text in the interview.
