LL.M. students have access to Cardozo's innovative clinics and other experiential learning opportunities during their second semester. Opportunities include:

## THE BUCHMANN FACULTY OF LAW, TEL AVIV UNIVERSITY

Cardozo School of Law is proud to have entered a new partnership with The Buchmann Faculty of Law, Tel Aviv University. Under this new agreement:

- All Buchmann Faculty of Law, Tel Aviv University exchange students who have finished a semester at Cardozo can apply to transfer to the LL.M. program upon completion of their degree requirements at Tel Aviv University.
- They can earn the LL.M. degree by completing an additional full-time semester at Cardozo.
- All credits earned in the exchange semester will count toward the 24 credits required for the LL.M. degree.
- This pathway allows Tel Aviv University law students to stay at Cardozo in consecutive semesters, transferring to the LL.M. degree after their exchange semester; or to return to Cardozo at a later term and complete the LL.M. semester within three years of their start of the exchange semester at Cardozo.
- Tuition charges will not apply during the exchange semester at Cardozo, guaranteeing students a cheaper and faster way of earning an LL.M. degree.

Tel Aviv University law students can choose to start their LL.M. semester in the spring or the fall terms. The number of students who wish to follow this pathway shall remain flexible, and we encourage all interested students to notify their international advisor of their plan to do so.
