#### **ACADEMIC EXPECTATIONS:**

<u>Admission</u> <u>Requirements:</u>	All Tulane Law School courses are taught in English. Students should be studying law and fluent in English, both oral and written. Tulane Law School requires the TOEFL unless otherwise waived. The minimum score is 90 on the internet based exam, 233 on the computer-based exam, and 577 on the paper-and-pencil based exam. Students may also take the IELTS, receiving a band score of 7.

## **REGISTRATION, COURSES AND GRADING:**

- Students are responsible for requesting an official transcript at the conclusion of their program to be sent to their home university. They can request a transcript via <a href="https://registrar.tulane.edu/transcript">https://registrar.tulane.edu/transcript</a>.
- Please see our <u>Course Descriptions Page</u> (reference previous semesters if not yet updated).
- Students can register for classes online through <a href="https://gibson.tulane.edu/">https://gibson.tulane.edu/</a> once they have been assigned a Tulane email address username and password (sent directly by the Tulane IT department).
- Exchange students can take any course offered by the Law School, subject to the prerequisites for any given course, with the exception of certain clinical and skills-related courses.
- Exchange students may take **one** non-law related class. Students should contact the non-law Tulane Department directly to receive approval. Students will receive a grade for this course on their transcript (separate from the law school). Students should check academic calendars and holiday breaks prior to enrollment, they may vary between Tulane departments.
- Exchange students take classes with JD and LLM students. Students should enroll as soon as possible to make sure that space is still available.
- Generally, exams cannot be rescheduled. Pay attention to exam dates when registering or booking travel.
- Exchange students will be graded on the normal U.S. grading scale (A-F). Students are encouraged to discuss the grading scale with their home school prior to arriving in the U.S. to avoid transfer credit issues after grades are posted.
- Tulane University offers exchange students the opportunity to transfer their exchange credits toward a future LL.M. degree. Students may be eligible to complete a Tulane LL.M. degree program in one semester with advanced standing. ## **ORIENTATION PROGRAMS**

#### FALL SEMESTER

- Tulane Law School holds a 4-week Introduction to US Law program for international LL.M. and exchange students before the fall semester. This program is worth 2 credits.
- If students want to consider an LLM from Tulane Law in their future education, they can complete the Introduction to US Law program prior to their fall exchange semester with waived tuition.
- The Introduction to US Law program also includes client workshops, writing sessions, tours and activities around New Orleans, and networking events with faculty and alumni.

#### **SPRING SEMESTER**

- Tulane Law School offers a 3 day orientation program prior to the start of the spring semester for new international law students. This program includes workshops, information sessions, tours, and networking events with current students (no course credits)
- Following the condensed law school orientation, spring semester exchange students will attend International Orientation with the Office of International Students & Scholars (OISS).
- Students should plan on arriving as early as possible to have more time to find housing and adjust to campus life (can arrive up to 30 days before semester start date). Housing can be very difficult to find in the spring semester.

## **ESTIMATED LIVING EXPENSES AND ADEQUATE FUNDING:**

- The Statement of Adequate Funding should indicate minimum funds of:
  - Introduction to US Law Program + Fall Semester <u>\$15,442</u>
  - Fall Semester -<u>\$12,964</u>
  - Spring Semester- <u>\$12,964</u>
  - Full Academic Year- <u>\$25,928</u>
- Included in this estimate is the mandatory Campus Health Fee and mandatory Tulane Sponsored Health Insurance Plan cost.
- These expense estimates are based on the previous academic year. Living expenses may vary within 3%
- Please note that adequate funding requirements are for immigration purposes and are based on estimates. Each student's actual expenses may vary depending on lifestyle.
- Students who take the Summer Intensive English Course will be charged tuition and should take into account an additional 2 weeks of living expenses.

### **HOUSING:**

- Temporary on-campus housing is available during July, prior to fall orientation. (Ends by August 1st).
- Students are responsible for arranging their off-campus housing for the academic term.
- Please visit the <u>Off-Campus Housing website</u> to explore housing opportunities, advice, and resources.
- <u>Deming Pavilion</u> is the only housing for graduate students (mostly medical), however it is located on the downtown campus which is 20 min from the Law School. There is a free shuttle between the two campuses. Deming is not recommended since all classes, activities and events will take place on the uptown campus.
- We recommend that properties **<u>not</u>** be rented sight unseen.
- You should plan on setting up temporary accommodations as you look for off-campus housing.

## **HEALTH INSURANCE & IMMUNIZATIONS**

- All J-1/J-2 visa holders must be covered by the <u>Tulane University Sponsored Health Policy</u> (TSHIP). TSHIP is not allowed to be waived for J-1/J-2 visa holders. Students will be automatically registered for TSHIP and billed through their Student Gibson Portal.
- The <u>Campus Health Fee</u> is a mandatory fee for all incoming Tulane students, providing them with access to the on-campus health center and university health and wellness resources.
- Exchange students must also complete <u>immunization requirements</u> through Tulane University Student Health Services. Please contact <u>immunizations@tulane.edu</u> with any questions.
